## Rector's Report 2024

St. James continues to be a healthy congregation with a promising future. Our participation in Vital & Thriving, a diocesan sponsored congregational development program, has fostered collaboration with our neighbors and is exploring ways to build on the work of our Faith in Action Team. From conducting a successful sock drive, monthly volunteer support, and annual fundraising for of Project Homeless Connect; to sponsoring and advocating for refugee families; and hosting a successful candidate forum for District One Supervisor candidates, we continue to be an outward facing congregation. St. James also made grants from our Outreach Fund to Episcopal Community Services and Sojourn Chaplaincy at San Francisco General Hospital.

One of the most significant changes this past year has been the transition to a new model of music program leadership and children's ministry at the 10 am worship service. We moved from a single Music Director position, to a two-person team of an accompanist and a cantor. We are fortunate to have Margaret Fondbertasse and Katherine Nägele-Lin in these roles. They are both gifted musicians, team players, and consummate professionals. Along with our dedicated volunteer choir, we have a solid foundation for the future of our music program.

Given our small number of families with young children, we also adapted the liturgy at 10 am to be more welcoming of children, including a weekly Children's Story before the sermon in lieu of Sunday school. This is working well, and we have a wonderful team of story tellers. It has added an element of joy and welcome to our worship, and challenges us to be inclusive of all ages as we sing and pray together. Our healing prayer ministry is a source of consolation and occasional miracles. Worship is the center of our common life, and it is a blessing to see attendance slowly growing in the second half of 2024, and new people joining us. I continue to be indebted to the Rev. Shari Young for her volunteer ministry of preaching, prayer, and pastoral care.

We also continue to foster the spiritual growth of adults in our community through a variety of weekly and seasonal opportunities to pray and study together. One of the most significant developments in this regard has been a growing collaboration with the Mary of Pentecost Community (MPC). MPC is an inclusive Catholic congregation that is part of the Association of Women Catholic Priests. They worship monthly at St. James (3<sup>rd</sup> Wednesday at 6 pm.) This past year, we shared a Lenten program and Holy Week Services with MPC, two quiet day retreats, and a summer book study. We also hosted the ordination service for one of their priests! I hope that this collaboration will continue and grow.

At St. James, we are blessed with strong lay leadership across the board. I'm particularly grateful for our vestry, especially our outgoing members: Senior Warden Jan Vennari, Junior Warden Ryszard Pochron, and Mary Balmana. They have given countless hours in service to our community. Managing the resources of our congregation is a sacred trust, and a constant challenge with our 100 year old buildings. Our Treasurer, Doug Bewsher, and our Finance Chair, Tom Matthews, have provided solid, shared leadership in this area. I am thrilled that they have agreed to continue serving in this capacity in 2025.

I also want to acknowledge the extraordinary service Elia Pochron has provided as the executor of the estate of Oi Yun Chow, of which St. James was a major beneficiary. Elia's stewardship of Oi Yun's generous gift to St. James of more than \$1.65 million will provide the resources to meet our medium-term needs for capital improvements to the church's buildings and grounds. And I would be remiss not to mention yet another Pochron – Erazm Pochron – whom we have employed as a contractor to oversee the Mechanical, Electrical, and Plumbing infrastructure project that is underway. Erazm has been a great asset in managing a complicated project with multiple players.

In my own ministry, I have assumed a larger role in diocesan leadership. I concluded my second year as a member of the Executive Council of the diocese in January 2023, and am serving as co-chair of the Strategic Visioning Committee, working closely with our new bishop, the Rt. Rev. Austin Rios. I plan to bring this work to its initial conclusion in October 2025, even though I will be retiring earlier in 2025.

My last Sunday with you will be March 2, the last Sunday after the Epiphany. Thereafter, I will be on sabbatical until my official retirement date of June 30, 2025. I am delighted that the Rev. Ron Willis will serve as part-time sabbatical priest, beginning March 3 through June 30. Thereafter, the vestry will be selecting a full-time Interim Rector to serve until the completion of the search process for the 9<sup>th</sup> rector of St. James. Next year's vestry will be guided by the capable leadership of Helen Archer-Dusté, who has agreed to serve as Senior Warden.

We will gather on March 1 at 3 p.m. for a Solemn Evensong with Bishop Austin to celebrate my retirement, followed by a festive dinner reception. Please mark your calendar to join us, so that I can share my heartfelt gratitude and bittersweet leave-taking with you then.

## Senior Warden Report

While 2023 was largely a year of reflection and renewal, 2024 was more formative—maybe even rejuvenating. We built on what we love and do best while continuing to explore new directions. Here are several stand-out areas that the vestry focused on this year.

We evaluated a comprehensive building program to upgrade many of the aging mechanical, electrical, and plumbing systems in our three buildings. Much of the work will literally be behind the walls so we won't see it, but it's important work to "take care our house" and improve safety for the St. James Preschool and all who are part of our community. We are blessed to have Erazm Pochron acting as project manager.

The generous property bequest we received from the Oi Yun Chow Estate provides a unique financial picture for St. James and our future. Elia Pochron, as executor of the estate, was hugely instrumental in orchestrating the receipt of this gift, and Tom Matthews graciously represented St. James through the sales process.

Early in the year, the vestry continued discernment based on insights and direction from the Vital + Thriving program. This resulted in identifying our missional challenge which Petrina Grube and the newly formed Missional Innovation Team are using to find opportunities to connect with others in our community. This discernment also highlighted other areas of importance to us, such as the role of music in our worship. Music at the 10:00 service has been greatly enhanced with the addition of Margaret Fondbertasse as our permanent accompanist and Katherine Nägele-Lin as our cantor.

Lastly, John's announcement of early retirement was unexpected for many of us. We've seen John grow so meaningfully as our pastor, spiritual guide, and leader that it's hard to imagine St. James without him. His notice gives us time to get used to the idea of him leaving, to grieve, to reflect, to plan, and not too long from now, to say our goodbyes. But thankfully, not just yet!

John made it easy for me to be senior warden, thanks to his vision, spiritual wisdom, organization, and his care for us. St. James is an amazing community of love, friendship, spirituality—dedicated to building a beloved community right here. I'm so grateful to be part of it.

## Junior Warden's Report

## **Deanery Report**

### **Deanery Convocation**

The 2024 delegates to the Diocesan Convention were Warren Wong (convener) and Mary Balmana with alternates Kristen Huber and St. John Barned-Smith. We are one of 16 congregations in the San Francisco Deanery with two delegates and two alternates representing us at the quarterly Deanery convocation.

The deanery meetings comprised four hybrid Zoom sessions plus an in-person summer potluck social activity with Bishop Austin Rios. This year's programs included delegate orientation, ministry formation, budget reports, nominations, resolutions, grants, and other preparation work for the Diocesan Convention.

The deanery officers were president Rev. Hannah Cornthwaite (St. Cyprians), vice-president - laity Regina Walton (Grace Cathedral), vice president - clergy Rev. Kira Austin-Young (St. Mary the Virgin), secretary Gretchen Lintner (St. Mary the Virgin), and treasurer Peter Fairfield (St. Aidan's). The two deanery representatives to the DioCal Executive Council were Father John Kirkley (St. James – until 12/2025) and Ms. Christine Bensen (Grace Cathedral - until 12/2026).

At the final deanery convocation, we elected the Rev. Kira Austin-Young (VP of clergy) and Gretchen Lintner (secretary) to full 2-year terms. Both serve at the Church of St. Mary the Virgin in neighboring Cow Hollow.

### **Bishop Transition**

- The Rev. Austin K. Rios, rector of St. Paul's Within the Walls in Rome, Italy, was elected as Bishop Coadjutor-Elect on the 2<sup>nd</sup> Ballot on December 2, 2023. He subsequently received the required canonical consent churchwide.
- On May 4, 2024, the Rt. Rev. Austin K. Rios was consecrated Bishop Coadjutor by Rt. Rev. Diane Jardine Bruce - Chief Consecrator and assisted by 20+ bishops during an Ordination Service at Grace Cathedral.
- During Trinity/St. Peter's Church's 175<sup>th</sup> Anniversary Service, the diocesan community celebrated Bishop Marc H. Andrus's final service on July 20, 2024, with a retirement event in San Francisco.
- Bishop Austin K. Rios formally was installed and seated during a special service at Grace Cathedral on August 11, 2024.

### **175th Diocesan Convention (October 25 - 26, 2024)**

Bishop Austin presided over his first DioCal Convention. The Diocese of California received five resolutions and three canonical amendments. The proposed 2024 DioCal Budget was approved, and action was taken on the four resolutions and three amendments to the diocesan canons. Warren Wong completed a short 2.5-year term opting not to continue on the Standing Committee. Thus, creating an extra lay seat, so one clergy, and two lay representatives were

elected. The Executive Council elected two large seats with nominees from four different deaneries (Alameda, Contra Costa, Marin, and San Francisco).

Starting in September 2024, Bishop Austin began a yearlong Strategic Vision Process Discerning God's Future for the Diocese of California: this Strategic Vision Process is underway. The Executive Council of the Diocese of California established a Strategic Vision Committee (SVC) to foster long-term planning and is chaired by Father John Kirkley. ## **Treasurer's Report**

2024 has been a consistent year for St. James on the operating side, with financial outcomes that broadly align with our budget in an overall position of financial strength. As we move into 2025 we will have a number of changes, but plan to have a balanced budget for the year.

### **2024 Revenue** (\$353,000 for 2024)

Our estimated 2024 Revenue was below plan, driven by lower than budgeted rental income. We also need to aim to fulfil all the outstanding 2024 pledges as we move into 2025.

- In a challenging San Francisco commercial real estate market, we experienced lower occupancy, with units/offices remaining un-rented throughout the year. While this reflects broader market trends in commercial leasing rather than specific issues with our spaces, we continue to prioritize efforts to maximize occupancy in the coming year.
- A significant positive development was the successful renegotiation of the Preschool rental contract. This adjustment reflects our strategic focus on long-term sustainability for our rental revenue streams, aligns their rates more closely with market comparables, and will lead to increased rental income over the next two years as the adjustments are phased in. This represents a significant step toward ensuring the sustainability of our rental revenue streams. Together with the underperformance in the room rentals, our rental income was \$14,000 below budget.
- Also on the positive side we achieved our fundraising event goal for the second consecutive year, raising over \$11,000—a testament to the incredible dedication and generosity of our community.

### **2024 Expenses** (\$362,197 for 2024)

Estimated Expenses for 2024 were very much in line with the budget, reflecting careful management across all categories. A key highlight was the successful hiring of both an outstanding Music Director and a talented Choralist, strengthening our music program and enriching our community's worship experience.

### **2024 Net Operating Loss**

The reduced rents resulted in a \$9,000 shortfall on an operating basis. In addition, we have not yet collected a number of pledges from before 2024 (\$10,651) which we chose to write off.

Finally the Vestry in December 2023 chose to put 2024's annual distribution from the endowment fund (\$19,000) towards the building fund this year, leading to an operating loss of \$19,727 for the year. While this loss for 2024 is significant, it stems from unpaid pledges and maintaining occupancy of the rental properties - both which are key to achieving an ongoing Operating Profit before any endowment distributions.

## **2024 Capital Accounts**

Our overall Assets continued to strengthen in 2024, with St James ending the year with \$951,000 in our Endowment Fund and \$73,000 in our building fund. With the upcoming sale of bequeathed property in hopefully Q1 2025, netting potentially over \$1.5 million, this puts us in a strong capital position and to be able to cover the planned investment in building improvements and our annual distribution to support the operating fund. .

## **Looking Ahead to 2025**

2025 is going to be a year of change. However, the outlook for St James on the financial side looks good to manage through the year.

## **2025 Planned Income**

Our budget foresees a similar income from contributions, rents and fundraising in 2025 as 2024, supported by a distribution from the Endowment of around \$24,000, based on the formula in the endowment fund policy for annual distribution at the start of each year, leading to a total income of \$372,000 for 2025.

## **2025 Budgeted Expenses**

On the expenses side, we are planning on the costs of a "Sabbatical" Priest during the period of Sabbatical between when John begins his sabbatical and his formal retirement date of June 30, 2025. This is not covered in our operating expense as it is a one off item related to when a Sabbatical is taken and we continue to pay the Rector while on Sabbatical which is part of our operating expense. We have then planned for an interim priest beginning from July 1st during our search process. Though the exact costs associated with this are yet to be finalized for the latter part of 2025, we are confident in our ability to manage these expenses within our overall financial plan.

In addition to inflation, there are a few other items (benefits, etc) that will increase our operating expenses slightly in 2025 to \$373,000. We plan no major operating expense increases or changes in 2025, as we go through the search process.

## **2025 Operating Break Even.**

Between our planned income, endowment distribution and expected expenses, we are planning a break even year for 2025. No doubt there will be changes throughout the year, but we are in a good position to adapt as needed.

## Closing Thoughts

St. James is in a strong position as we navigate these transitions and opportunities. Our financial foundation, bolstered by prudent planning and a growing endowment, ensures we can adapt to changes while continuing to serve our community. ## Finance Committee Report

The Finance Commission is the group that oversees the finances of St James' Episcopal Church – including the operating fund, building fund, outreach fund, and endowment fund.

The Commission meets quarterly, with additional meetings as necessary. The commission met 4 times in 2024 in this capacity.

During 2024, our work included the following –

- Completed renewal of lease agreement with SJPS – effective 1<sup>st</sup> July 2024
- Review of the insurance coverage of the Church – including renewal, consideration of higher deductible, and ensuring adequacy of coverage.
  - Will be moving to a higher deductible to balance coverage with costs in steps – from \$1k in 2024, to \$5k in 2025, to \$25k when MEP project is completed (e.g., water valve shut off and fire alarm – to mitigate damage / enhance safety)
- Reviewed acquiring earthquake insurance – and, recommended to decline / vestry approved based on cost of premium
- Review, update, rebalance investment allocation for building and endowment funds – including adding a socially responsible fund (rebalancing normally done in late Spring / early Summer – but, in 2024 completed in December)
- Review and retain coverage of the Balboa flats that were bequeathed to us very generously in Oi Yun Chow's estate.
- Ready and commencing sale of Balboa flats
- Participated in MEP building design planning

## **Stewardship Committee Report**

Many thanks to committee members Ann Alpers, Carla Cooper, Dave Davies, Blake Hallanan, Tracey Thomas and the Rev. John Kirkley. Highlights of the year included a very successful Harvest Festival fundraising event in September, which raised more than \$10,000. Our Fall Pledge Campaign has secured pledges totaling \$195,000 as of December 31, 2024, with a goal of \$210,000 in pledges for 2025. We still anticipate some pledges coming in. Please see the list of pledging households below, and let us know if you wish to make a pledge if we have not yet received it.

In addition, St. James received a significant bequest from the estate of Oi Yun Chow in 2024: a 3-unit residential property at 3009-3011 Balboa Street. The property is currently in escrow pending final sale. The proceeds are designated for St. James Endowment Fund per the bequest. We all owe an enormous debt of gratitude to Elia Pochron, who is serving as trustee of the estate and has managed a very complex process. Tom Matthews, our Finance Committee chair, has overseen the sale of the property on our behalf.

## Vital + Thriving Report

Sponsored by the Diocese of California, Vital + Thriving is a multi-year program to foster congregational revitalization and missional creation of the Beloved Community. In 2024, the St. James' congregation participated in these developmental phases.

At the January 2024 Vestry Retreat, we discussed the key themes from the Congregational Discernment event held in Nov. 2023. We identified functions for which the Vestry would be responsible and defined an initial high level missional challenge for our Missional Innovation Team: “*Serving as a convener to address community and social justice issues.*” This missional challenge will continue to be refined as we develop connections with community partners and discern where the Holy Spirit is leading us.

Actions in 2024 included:

- Recruited key members for the Missional Innovation Team (MIT). Petrina Grube continued from the initial Steering Committee to serve in this next phase, along with new members Blake Hallanan, Wy O'Connor, Leo Balambao and Roger Wickstrom.
- The MIT has met regularly throughout 2024, conducted several community connection interviews, and continued to explore where and how the Holy Spirit is guiding us.
- The MIT and Vestry representatives attended the April and Oct. 2024 ingathering events sponsored by Vital + Thriving as well as holding a consultation with the V+T leadership in November.
- In partnership with Project Homeless Connect and the St. James Preschool, the MIT sponsored a sock drive in Dec 2024.

We invite congregational participation in these efforts in the coming year as we continue to explore how St. James is being called to partner with others in our wider community to be a vital and thriving part of growing the Beloved Community here and now.

## **St. James Faith in Action Report**

Faith in Action is a ministry of St. James focused on social justice issues affecting parishioners and our community. Our collective efforts during 2024 were directed primarily at homelessness and housing justice issues. We hold bi-monthly meetings to provide updates and plan for future activities.

### **Project Homeless Connect**

Our work with the PHC CareVan gives opportunities to volunteer to bring services to our homeless and housing insecure neighbors. The primary activity is the monthly outreach walk. Volunteers, including Ed Wilcox, Margaret Stark-Roberts, Tom Matthews, Barbara Webb and Sandra Dratler, pair up and go into the neighborhood, distributing hygiene kits and encouraging those in need to visit the PHC remote site set up at 7<sup>th</sup> and Geary to meet with counselors that day.

Members of St. James and friends joined others at Bill Graham Auditorium for the quarterly Project Homeless Connect Community Days of Service. On that day, people are provided with needed medical, dental, housing and DMV services among others. This is an impactful event - both for participants and the volunteers. Helen Archer-Duste, Scott Golde, Barbara Webb and Sandra Dratler provided their time to this activity this year.

The 3<sup>rd</sup> Annual Craft Sale organized by Elizabeth Nelson held in October resulted in a donation to Project Homeless Connect amounting to over \$1,000. St. James Youth and St. James Pre-School students held a sock drive over the Christmas holidays that benefited Project Homeless Connect.

Barbara and Sandra also put together special Christmas bags that included hygiene items and toiletries with extra socks, gloves and Christmas cookies. They were distributed just before Christmas in the name of St. James Faith in Action.

### **Evening Prayer**

SJFIA led six Wednesday Evening Prayer Zoom services ranging from a summer revival to prayers for peace and hope in this trouble world. The services are well-attended and well-received. Plans are already laid out for next year. Please join us!

### **District 1 Supervisor Candidate Forum on the Future of Housing in the Richmond District**

St. James Faith in Action and St. John's Presbyterian Church co-sponsored a well-attended forum for District 1 Supervisor Candidates on the future of housing in the Richmond District. The forum was held on Thursday, September 26 from 7-8:30 p.m. at St. James. Housing issues addressed included creation of affordable housing for low- and middle-income residents, tenant protections, providing services and living situations for our unhoused neighbors, and understanding the implications of new legislation on the height and density of housing on our main corridors and corner lots. All five supervisor candidates participated.

Faith in Action at St. James also provided testimony several times before the Board of Supervisors committees and Planning Commission advocating for more truly affordable housing in the City.

### **Richmond District Advocacy Groups**

SJFIA has continued its efforts to collaborate with other social justice organizations in the Richmond District. To that end, Richmond District Rising and West Side Tenants Association are now holding their general meetings at St. James.

### **Other Activities**

Individual members of SJFIA were active participants this year in environmental and immigrant justice including issues related to contamination at Hunter's Point, accompanying newcomers from Ukraine and collaboration with Interfaith Movement for Human Integrity accompaniment of immigrants.

This report also wishes to recognize the many unsung/unnamed heroes and heroines of St. James who put their faith into action every day through prayers and their own community activities.

## **Gardening Ministry Report**

The grounds of St. James are maintained by Elizabeth Nelson, Margaret Stark-Roberts, and Peter Krag.

There are five small garden plots scattered around St. James' grounds: the rose bed, the children's bed east of the nave, the bougainvillea bed to the west and privet hedge east of the entry gate, and the secret bed off the alley west of the nave – which we call Debbie's Garden, after Debbie Sham.

In 2024, the rose bed was replanted. Several of the roses and rosemary plants were removed; four new roses were added, and two roses and one of the rosemary plants were transplanted. The large Podocarpus ('Brother Tree') had major (professional) pruning, and several new plants and mulch were added under it. The street tree wells were mulched, which has helped with weed control. The secret bed, children's bed and the bougainvillea saw no work other than routine maintenance chores.

  - \* The Finance Committee passed resolution within the vestry to annually pull 4% from Endowment to the operating budget.

It will look at the identity of the Diocese and make recommendations to the Bishop and Council about how to align practices and ministries with the vision of the Beloved Community. This work is rooted in the Executive Council values of spirituality, church vitality, inclusive community, and transparent and accountable leadership.

\* As part of this focus on change and the future, John has been referring to Meg Wheatley a management consultant and the author of Who Do We Choose To Be? Her key questions are: Where are we (St. James, Diocese) on the arrow of time? How adaptive is the Diocese as a living system?

\* Meg Wheatley has 6 principles of living systems that allow organizations to be vital and adaptive. The congregation broke out into groups to discuss each of them. Summary discussions follow:

Quality of Thinking: V+T gives us intentional time to think about the future. It would be valuable to maintain it on a more ongoing way. Parents have valuable time to be intentional during church when kids are in Sunday School or nursery. Sacred Ground represents important thinking, as do small group learning groups (book groups, John's offerings). Programs need to be intentional to have the most meaning and relevance. One question becomes how to get the message out to the community about what's going on here. There's interest in carving out time between Vestry and congregation; how to include everyone.

Willingness to Contribute: The group talked about the importance of how you ask people to do things so they say "yes". We generally have a flat level of financial contribution from a smaller number of donors. The goal is to ask new people to contribute. At the other end of the spectrum, we are burning out people by asking them to contribute too much/too often. We need a change management and growth mindset: Change is hard; people object; need to share context and why to help people move through change. Having a growth mindset helps our willingness to adapt and feeds into willingness to contribute.

Fear vs Love: We are a loving community – it keeps us here. One can sense love when they walk through door. It's seen in Life Changes where we see people's vulnerability. We don't use fear to motivate; our sense of love is greater. The group agreed that we don't feel judged; can be ourselves without judgement. A fear we had in the past was centered around the potential creation of the Community Learning Center. That fear didn't linger; Won Jae Hur, as interim rector after the CLC was dissolved helped recenter us.

Quality of Relationships: People became accustomed to being remote and are now more elective and protective of their time – so we need incentives.

Crisis Management: We do well overall. We recognize when there's a problem, reach out, communicate clearly, generally stay calm. We may not speak openly about the issue; it may be addressed by small group and not those who could resolve it. We don't have processes in place to solve problems and John often ends up as a mediator. People who are more involved at St. James have more trust with each other from their time together; it dissipates further out the circle.
